Sandra Roberts mentioned that her name should be deleted and Sandra Lopez should be added regarding the plastic display cases. Emily Irwin asked Virginia to highlight changes beginning with the June minutes. Dan Winner made the motion to approve and Mike Arias seconded.

## Fiscal Update (Randy):

The current balance at the end of the second quarter is \$7,127.89. Income collected in the second quarter was \$1,080.32. Total expenditures in the second quarter was \$1,110.27. For the second quarter there was a negative cash flow of

\$29.95 (attachment #1 - Second Quarter Fiscal Summary).

Emily asked if we should increase the membership dues to keep even with the costs of sending out the newsletter. As of now, the cost is approximately \$1100.00 per guarter. Printing the newsletter is about \$900.00 and mailing it is an additional \$200.00. Jan raised the question of changing vendors and the possibility of lowering the cost of printing. Per Sandy, if we change, it may be more expensive. The current vendor takes the electronic file prints and mails. Emily stated the cost of printing and mailing each newsletter is approximately \$18.00. Raising the dues to \$20 would cover the newsletter costs. Jan asked about the possibility of sending out three newsletters per year instead of four. Per Cyndie, we need four newsletters because of the dates of the Quemado Lake Roundup and the picnic. Per Jan, electronic newsletters is the goal. Dan stated that raising the dues from \$15.00 to \$20.00 is not going to bankrupt anyone. Also, reducing the quantity printed per quarter will likely raise the cost per newsletter. Over the last few years input from members is that they want to receive a hardcopy of the newsletter. The electronic option will remain an available option should members change their minds. Emily asked for brainstorming ideas of how to let members know of an increase in dues coming and to change the charter to increase by more than \$5.00. Per Dan, instead of changing the charter, just raise the dues \$5.00 per year. Cyndie Hogg made the motion to approve the fiscal report and Jan Pulaski seconded.

### Welcome Letter (Emily):

At the March meeting, Emily discussed sending out a welcome letter to new members. She typed one up and sent it out to the board members. All attending the meeting agreed that a welcome letter is a good idea. Sandra will forward information to Emily to include in the letter. Cyndie will send out the letter under the Amigo's communication email profile. Randy will forward Cyndie the names of two new members. Cyndie will mail the letters out after the 1<sup>st</sup> of July. Cyndie automatically snail-mailed Bill Burbridge and Buck Wickham newsletters. Buck's son is taking over for the duration of Buck's Amigo's membership.
